Purpose: To Transfer Trustee Funds to General Fund, discuss disposal of Old Windows and Completion of New Window Project, and discuss Personnel Issues & Customer Complaint.

Call Meeting to Order

President Sandy Neiman called the meeting to order at 2:01 p.m.

Adoption of Agenda

Judy Bettmann made the motion to approve the agenda with addition of "Announcments" by Bob Brummond, CEO.

New Business

<u>Transfer of Trustee Funds to General Fund</u> - Bob Brummond submitted his request for payment. Razor still has issues. Bills went to self pay instead of insurance. Medicare was also kicked back for September, and not paid. Medicare – the account to repay Medicare has +- \$600,000.00. Will need + \$80,000.00.

Request: from the Trustee Account. \$156,918.42 = \$56,918.42 = \$100,000.00.

Invoices to be paid by November 30th include \$326,381.20.

Judy Bettmann moved to transfer \$150,000.00 from the Trustee Account to the General Fund. ____ seconded.

<u>Disposal of Old Windows and completion of New Window Project</u> -11 windows are ready for pick up. Judy Hutchinson and/or Sandy will pick them up. Balance on windows is \$89,687.12 less \$12,000.00 (in Trustee account) = \$77,687.12. Cost is \$1,825.00 over. They needed 24 re-dos instead of 18 on windows. Door replacement is on a separate contract.

Connie made the motion to transfer \$12,000.00 funds designated for windows from the Trustee account to the General Fund. Judy Bettmann seconded the motion. Motion carried.

Three door replacements. To bring up at next meeting.
